

**AGENDA ITEM No.10****CONSIDERATION FOR ENHANCEMENT OF THE UPPER AGE LIMIT IN DIRECT RECRUITMENT POSTS BY ADOPTING THE G.O.Ms. NO. 30 DATED 08.02.2024 OF GENERAL ADMINISTRATION (SER-A) DEPARTMENT, GOVT. OF TELANGANA.**

The Finance (HRM.VII) Department, Government of Telangana vide G.O.Ms. No. 140 & 146 dated 30.08.2022, has accorded permission with regard to filling up of fifty (50) and Eleven (11) vacant posts in various categories under the control of Managing Director, Telangana State Warehousing Corporation, by way of Direct Recruitment through Telangana State Public Service Commission.

The Government of Telangana vide G.O. Ms. No. 42 dated 19.03.2022 of General Administration (Ser.A) Department, Government of Telangana raised the maximum age limit for appointment by Direct Recruitment up to 44 years. Accordingly, the sanctioned posts meant for Direct Recruitment in Telangana State Warehousing Corporation were notified to Telangana State Public Service Commission. The subject was placed in 18<sup>th</sup> Board of Directors meeting of TSWC held on 28.09.2022 and the Board of Directors ratified the action taken by the Managing Director.

The Government of Telangana vide G.O.Ms.No.30, General Administration (SER.A) Department, dated 08.02.2024 have issued an ad-hoc rule by raising the upper age limit from 44 years to 46 years prescribed in Rule 12 of State and Subordinate Service Rules. (Annexure-I).

Accordingly the following notification shall be published in the Telangana State Gazette.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Telangana hereby makes the following ad-hoc rule:-

*"Notwithstanding anything contained in the Telangana State and Subordinate Service Rules, 1996 or in the Special or Ad-hoc Rules for State and Subordinate Services, the maximum age limit prescribed in the said rules for appointment by direct recruitment shall be raised further "two (2) years" in addition to "ten (10) years" already raised in the Ad-hoc rule issued vide G.O. Ms. No 42, General Administration (Ser.A) Department, dated 19.03.2022, for a period of 2 years from the date of issue of this Ad-hoc rule to the various categories of posts to be notified for the purpose of direct recruitment, by all the recruiting agencies in the State. The age concession over and above the upper age limit shall also be allowed in accordance with the Rule 12 of the State and Subordinate Service Rules. Provided that nothing in this rule shall apply for direct recruitment to the posts of Uniform Services viz., Police, Excise, Fire, Prisons, Forest Departments etc., for which physical standards have been prescribed in the State and Subordinate service Rules or in the relevant Special or Ad-hoc rules".*

This ad-hoc rule shall be in force up to 2 (two) years from the date of issue of G.O.

According to Telangana State Warehousing Corporation Employees Regulations, Appendix III (Regulation 6), (amended in the 18<sup>th</sup> Board of Directors meeting held on 28.09.2022) the upper age limit for filling up of various posts in Telangana State Warehousing Corporation for direct recruitment is 44 years.

The subject is placed before the Board for adopting the G.O.Ms. No. 30 dated 08.02.2024 of General Administration (SER-A) Department, Govt. of Telangana by raising of upper age up to 46 years in Telangana State Warehousing Corporation for Direct Recruitment posts.

**ORDER:**

Government issued orders on raising the maximum age limit prescribed in the Telangana State and Subordinate Service Rules, 1996 for appointment by direct recruitment by "Ten years" i.e., from 34 years to 44 years, for a period of 2 years, to the various categories of posts to be notified for the purpose of direct recruitment, vide G.O. second read above.

2. A number of representations have been received from unemployed youth, for considering relaxation of upper age limit for direct recruitment to enable more unemployed youth to become eligible for recruitment to the various categories of posts.
3. The Secretary, Telangana State Public Service Commission, Hyderabad in the letter third read above, inter alia, has requested the Government to raise the maximum age limit for the posts other than the Uniform Services, further by two (2) years in addition to ten (10) years already raised in the G.O. 2<sup>nd</sup> read above.
4. Government after careful examination of the matter, have decided to raise the maximum age limit from 44 years to 46 years to other than Uniform Services, for a period of two years.
5. Accordingly, the following notification shall be published in the Telangana State Gazette, dated:08.02.2024:-

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Telangana hereby makes the following Ad-hoc rule, namely:-

**AD-HOC RULE**

Notwithstanding anything contained in the Telangana State and Subordinate Service Rules, 1996 or in the Special or Ad-hoc Rules for State and Subordinate Services, the maximum age limit prescribed in the said rules for appointment by direct recruitment shall be raised further by "two (2) years" in addition to "ten (10) years" already raised in the ad-hoc rule issued vide G.O.Ms.No.42, General Administration (Ser.A) Department, dated:19.03.2022, for a period of 2 years from the date of issue of this ad-hoc rule to the various categories of posts to be notified for the purpose of direct recruitment, by all the recruiting agencies in the State.
